On 6/24/2026, while working under the Violence Reduction Strategy Unit I attempted to serve an active warrant for ALLISON BROOKE YATES (Suspect/Arrestee) at 15867 Baxter Creek Drive under CCR 26-370852

Once on scene, I made contact with the suspect in the front yard and placed her in double locked handcuffs (Positioned in the front due to pregnancy) and placed her in my marked JSO patrol car.

I then read the suspect her Miranda Rights Via card and asked about the case below.

Your affiant has been employed by the Jacksonville Sheriff's Office as a sworn officer for a period of six years.

On 04/10/2026, your affiant responded to 5143 Hood Road, in reference to a report of a fraud. Upon arrival, your affiant made contact with the listed victim, Terri Widdick.

The victim advised that she purchased a puppy through the website puppies.com. The victim provided screenshots of the transaction process to me. The victim advised that she was supposed to buy a Doberman puppy with the ears docked. This deal was agreed to in text message. It should be noted that all of the messages were from the number 904-805-4377. The profile name of the seller was Allison Yates (defendant). It should be noted your affiant was able to locate the listed defendant with the same name based on the phone number provided. The defendant previously gave the number to the police in another incident (25-469435).

The victim advised that on 04/07/2026, she met a male at a gas station (413 Pecan Park Road, per the agreement). The victim paid 3000 dollars and received the dog. The victim advised the dog's ears were wrapped up and she was told by the male to leave them wrapped for a few days.

A few days later, the victim unwrapped the dressing on the dog's ears to find that the dog's ears were not docked. Furthermore, the victim investigated the certificate of health given to her and realized it was fraudulent.

The victim advised that the dog had an ear infection due to the ears being wrapped. She estimated it would cost around 1000 dollars to dock the ears of the dog through a private vet. The victim provided me with a copy of the fraudulent certification, the pictures of the dog with ears docked as provided to her, a picture of the dog she received, and the profile information for the defendant.

Your affiant went to the address of the defendant and made contact with her. Your affiant informed the defendant that she was not under arrest, so Miranda Warnings were not required. The interview took place outside the defendant's home where she was free to walk inside at any time.

The defendant originally stated that she never sold any puppies to the victim but later admitted to it when confronted about the text exchange. The defendant stated that the victim could take her to court if she had a problem with the transaction.

Further investigation revealed that the Health Certificate provided by the defendant was fraudulently created. Dr. Nelly Amador Jehn, (DVM, MS Veterinarian Manager-Small Animal Programs) examined the certificate and advised that the health certificate had several fraudulent items to include the Veterinarian accreditation numbers being wrong, and the Vaccine number being from a different dog in 2023.

Post Miranda the suspect advised that all she did was text the victim via phone and was not involved in the exchange of the dog. She advised that she only deals with French Bull dogs and that her husband YASMANI ACOSTA, is the one who sells and deals with the Dobermans.

She provided no other statements.

ID/ Records was called and ID# 7934 advised that the warrant was active.

The suspect was then transported to the PTFD.

Case cleared by arrest, Warrant served.


